According to the North Sea Commission charter, political positions are elected for a period of two years. The positions are renewable.

The following position will be elected at the Annual Business Meeting June 2019:

One NSC Vice-President position (currently held by John Lamb) – for the period from the ABM 2019 to the ABM 2021.

The following positions are to be elected at the Executive Committee June 2019:

Chairs of all thematic groups - for the period from the summer ExCom 2019 to the summer ExCom 2021.

In case one of the Vice Chairs is elected to the position as Chair, there will be also a subsequent election of new Vice Chair for the period until the summer ExCom 2020, when all Vice Chair positions are up for election.

We kindly request all current position holders, whose positions are up for election, to confirm as soon as possible if they intend to restand and possible new candidates to submit their candidature.

All new candidates are requested to submit their application and CV to the NSC Secretariat. **Please note that the deadline is the 15th of May**

The Annual Business Meeting will also confirm the **national representatives in the Executive Committee** (one

representative and one substitute representative from each country, nominated by the members in that country). Member regions in each country are kindly requested to agree on their nominations before the ABM. We ask the contact persons in the regions of the current national representative to inform the secretariat of the nomination.
