Annual Business Meeting 25 June 2019 - it's a wrap!



The North Sea Commissions members gathered at the NSC Annual Business Meeting (ABM) on 25 June 2019 in Marstrand, Sweden.

Reflecting on the year passed, President Kerstin Brunnström emphasised that whilst it's been a year of changes and uncertainties, with elections in several North Sea regions and a yet looming Brexit, the North Sea Commission has had a very active year. Looking at the <u>2019-2020 NSC Action Plan</u> adopted at the ABM, the busy times will continue.

It has also been a year of changes for the NSC. President Kerstin Brunnström thanked Vice-Chair John Lamb, Southend-on-Sea, for his many years of engagement and welcomed Peter Argyle, Aberdeenshire as new Vice-Chair of the NSC.

Several external guests where invited to discuss current strategic issues for the NSC. Eva Maria Gram from the Danish Ministry of Energy, holding the presidency of the North Seas Energy cooperation gave an update on its developments. Nicholas Brookes, CPMR Executive Director, informed about its work on a CPMR manifesto, which is the strategic document on which the CPMR lobbying efforts will be built around. Talking about the future of territorial cooperation, Christian Byrith, Director Joint secretariat at the Interreg North Sea Region Programme, reported that informal meetings to prepare the next programming period had started.

Marstrand Declaration

Adopted by the CPMR North Sea Commission Annual Business Meeting 25 June - Marstrand, Sweden

The regions of the CRMR North See Economistion (NSS) met in Marstrand (Vastra Gotaland, M) on the 25° of June 2019 for the 15° NSS Annual Equinest Meeting. On behalf of its members, the North See Commission wishes to convey the following messages:

On 25 June the North Sea Commission Annual Business Meeting adopted the Marstrand Declaration. With the Declaration the NSC members urges the EU and national governments to ensure immediate action to tackle the climate emergency, adopt an ambitious agenda for Europe until 2030 and work towards strong North Sea cooperation in the Brexit era.

Important steps taken for youth involvement at ABM



During this year, the NSC took important steps towards an integration of youth perspectives into the workings of the NSC. Besides having organised a <u>Youth Parliament Council</u> earlier this year, youth representatives Isla Young (Aberdeenshire), Merit Katerborg (Groningen) and Andrea Risholt (Aust-Agder) were invited to the ABM and the North Sea Conference.

The ABM urged the NSC members as well as the Executive Committee and thematic groups to involve young representatives in the regular work of the NSC. It was also decided to recruit a youth advisor to help develop youth participation within the NSC.

One of the top priorities of the NSC is marine litter. At the North Sea Climate Conference on 25 June 2019, the plans for a public transnational river clean-up campaign next year was presented by Kerstin Brunnström, NSC President, and Yolanda Schmal, advisor to the Marine Resources Group. It is a joint initiative by NSC and KIMO, the European association of municipalities for sustainable seas, to engage citizens and raise awareness of the issue of marine litter.

All NSC thematic groups met before the Annual Business Meeting in Marstrand, Sweden, on 25th June 2019.


The Marine Resources Group organised a Beach Clean-up

After almost two hours, nearly 20 bags full of marine litter, including larger items like a fish crate all the way from Scotland, was collected.
